Israel Destination (Yaad Yisrael) is honored to work with NEFESH International on its upcoming Israel Solidarity Mission. The itinerary for the 4-day, 3-night trip will be developed together with Dr Holzer and will incorporate the organization's priorities and preferences.

Specifically, the program would include the following:

- 3 nights in the Cassia Hotel with breakfast
- 4 lunches and 3 dinners (one night you will be free to eat on your own). The closing dinner will be in a private room. 2 boxed lunches, 1 light café and 1 lunch at a winery. All meals are mehadrin.
- Air-conditioned/heated bus for 4 travel days, 12 hours daily
- Logistics professional or a licensed tour guide accompanying the group
- Planning and implementation of itinerary
- Full logistical support services
- Emergency Medical Insurance

Cost:

We expect the costs to be under \$2500.00pp based on 25 participants.

Single occupancy upgrade \$620pp

If we have a larger group, we should be able to offer a lower cost.

Sponsorships may also bring down the cost.

This proposal is valid with a minimum of 25 paying participants and the usage of 10 hotel rooms. Anyone wanting to attend the program without a hotel stay will be given an independent price quote based on the amount of full paying participants.

Not Included:

- International Airfare
- Travel insurance
- Armed guard
- Gratuities (approx. \$12 per day per person)
- VAT for Israeli citizens traveling as members of the delegation
- Donations, meals with guests, speakers' fees or room rentals that go beyond the delineated amounts listed above
- Hotel accommodations for Sunday or Thursday night are available at an extra cost.
- Visiting guests who join for part of the program or any of the meals

Payment Terms

1. **Deposit**
Client shall pay a non-refundable deposit equal to **thirty percent (30%) of the total trip price** no later than **March 10th**
2. **Final Payment**
The remaining balance of the total trip price shall be paid in full no later than **April 13th**.
3. **Failure to Pay**
Failure to remit payments by the dates specified above may result in cancellation of the Client's participation in the trip.

Cancellation and Refund Policy

1. **Cancellations Prior to April 13**
In the event the trip is canceled by the Client prior to **April 13**, all payments made shall be refunded **except for the non-refundable deposit equal to thirty percent (30%) of the total trip price**.
2. **Cancellations on or After April 13**
In the event the trip is canceled by the Client on or after **April 13**, **no refunds shall be issued**, and the Client shall be responsible for the full cost of the trip.
3. **Participant Reductions**
Notwithstanding the foregoing, the Client may reduce the number of participants by up to **ten percent (10%) of the total confirmed participants** without penalty, provided such reduction is communicated to the Provider in writing no later than **April 10th**.
4. **Excess Reductions**
Any reduction exceeding ten percent (10%) of the total confirmed participants, or any reduction communicated after April 9, shall be treated as a cancellation and shall be subject to the no-refund policy described above.
5. **Terror/War-Related Cancellation**
The Client is aware that in the past there have been acts of terror and instances of war, which must be regarded as an additional risk of travel in Israel, and accordingly, cancellation due to any US State Department warnings, fear of travel, illness or any other reason will be deemed a cancellation and shall be treated in accordance with the aforementioned cancellation policy. Notwithstanding the foregoing, in the event of cancellation by the Client due to official notifications/warnings by the Israeli government and/or anyone of its behalf from security/safety reasons, ID shall exert reasonable efforts to refund all recoverable costs.
